Nomination criteria:

- Nominee must be a member of CVMA for the past 10 years or more
- Nominators must be CVMA members

Nominations must include the following:

- A completed nomination form accompanied by a petition signed by five colleagues of the nominee who have been members in good standing of the Association for the preceding ten or more years.
- A synopsis of nominee's qualifications
- A minimum of three letters of recommendation detailing this individual's community involvement and service, not to exceed five letters.
- Relevant published material (newspaper or magazine articles internet hyperlinks, video/audio acceptable) not to exceed five pages.

All submitted material becomes the property of the CVMA and will not be returned.

This award will be presented at the local VMA meeting and the recipient will be recognized in the *California Veterinarian* magazine.

Nominations will be accepted from September 15 through January 6, 2023. Please submit the completed nomination form with supporting materials to the CVMA by January 6, 2023.
