The Distinguished Life Membership is CVMA's highest membership category. It is awarded to an individual of the highest caliber in the profession who has been a member for a period of 25 years, has gone above and beyond the ordinary dues-paying obligations, and has actively participated in CVMA responsibilities.

Nomination criteria:

- Nominee must be a member for at least 25 years, including the preceding five years
- Nominee must have actively participated in CVMA responsibilities

Nominations must include the following:

- A completed nomination petition
- A synopsis of the individual's active role(s) in CVMA membership and their responsibilities/positions held.
- Signatures of five colleagues of the nominee who have been members in good standing of the Association for the preceding ten or more years
- Three letters supporting the nomination.
- A digital photo of the nominee (minimum 300 dpi)

All submitted material becomes the property of the CVMA and will not be returned.

Presentation of the award shall be made during CVMA's Awards Ceremony at the annual Pacific Veterinary Conference in June. The recipient will be recognized in the *California Veterinarian* magazine.
